

Instructions: Application for Membership and/or Reenrollment

It is important that the online application be completed correctly. Any missing or improper information may delay the application process and could result in it becoming necessary to resubmit the form or in rejection of membership.

LINE-BY-LINE INSTRUCTIONS FOR APPLYING ON LINE!!! PLEASE READ AND FOLLOW CAREFULLY.

1. Academic Year: (Required) Choose the year from the drop-down menu.
2. Applying For: (Required) Choose the one that applies to your situation.
 "New Homeschooler"- has not homeschooled before and are withdrawing children from school or have children who are becoming school-age that have never attended any school.
 "Reenrollment"- your family is presently or has been a member of PACESC.
 "Transfer from state or group"- presently a homeschool family moving into our state or has been a SC homeschooler under some other organization.
3. Member ID: Applies ONLY to homeschoolers reenrolling. The Member ID is the number that can be found on your prior membership card and confirmation letter. *(All New Homeschoolers and Transfers will leave this area blank. An ID will be assigned to you once accepted.)*
4. List State or Group: Applies to Transfer applicants only. (All New Homeschooler and Reenrollment applicants will leave this area blank.)

Items 5 through 10 are about the parents/ legal guardians living in the home...

5. (1) Parent/ Legal Guardian: (Required) Full name of the parent or legal guardian of the student(s) being homeschooled. This person must live in the home and have legal custody and/or court appointed guardianship of the student(s).
6. (1) Education: (Required) State requires that the teaching parent/legal guardian have at least a GED. If you answer "NO..." to this item; then item #7 must be answered "NO" also. At least one parent/ legal guardian listed in item 5 or 8 must have at least a GED noted in items 6 or 9.
7. (1) Teaching: (Required) Choose the one that applies.

For items 8,9,10... You may enter another person if applicable. See items 5,6,7 for instructions. You may leave these blank if there is no other parent/ legal guardian living in the home.

Items 11 through 21 are about where the family physically lives and where to send mail...

11. Phone Number: (Required) List a contact number.
12. Alt. Phone: You may list an alternate number is one is available.
13. Email: You may list an email. You can be assured that we will never distribute or sell your email address. It is helpful to relay important information promptly by email and helps to keep postage costs down.
14. Street Address: (Required) This is your physical address and can not be a PO Box or rural route number.
15. City: (Required)
16. State: (Required)
17. Zip: (Required)

For items 18,19,20,21... You may enter an alternate address to receive your mail. This can be a PO Box, rural address, or alternate address. Please when completing, complete all items or leave all items blank. Not necessary if you will be receiving your mail at the address listed in items 14,15,16,17.

Item 22 is VERY IMPORTANT... We must have the school district that your children would be attending if they were in your local public school. This information must be accurate. If you do not know which district you are in, you may use the lookup tool located on the SC Dept of Education's website at

25. (1) Student Grade: (Required) Grade Level. Repeat for additional students in items 30,35,40, and 45 if needed.
26. (1) Student Will Be: (Required) Choose the appropriate placement. Repeat for additional students in items 31,36,41, and 46 if needed.

27. (1) Enrollment Issues: (Required) Choose the appropriate placement. Repeat for additional students in items 32,36,42, and 47 if needed.
48. Name: (Required) Please enter the name of the person completing this form. It may be the applicant or another person completing the form on their behalf.
49. Date: (Required) Please enter the date this application is completed and submitted.
